MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made between:

herein individually or collectively referred to as a "Party" or the "Parties".

NOW THEREFORE IT IS HEREBY AGREED AS FOLLOWS:

Article 1: Definitions

- 1. Words and expressions defined in the Metamorphose NoE EC Contract 500252, including its Annex I, have the same meaning in this Memorandum.
- 2. <u>However, only the above mentioned institutions are considered as *Parties* for this <u>Memorandum.</u></u>

SECTION A. SUBJECT, PERFORMANCE AND DURATION

Article 2: Subject and Scope

- 1. The subject of this Memorandum is to specify with respect to the Project the organization of the work between the Parties, to organize the management of the Project, to define rights and obligations of the Parties, including, but not limited to, their contribution, liability and indemnification, and to supplement the provisions of the Contract, including those concerning Access rights and to set out any other rights and obligations of the Parties related to the Project, but not conflicting with those of the Contract.
- 2. For the avoidance of doubt, the rights set forth in this Memorandum shall only extend to the Parties hereto in their own legal personality and capacity and shall not extend to any third persons or parties even if such third party should be an affiliate of a Party. No special rights or status are recognized for affiliates of Parties, which are not Parties to this Agreement in their own right. Unless provided otherwise in this Agreement or by mandatory law, no such rights may be

assigned by a Party to a third party without having obtained the prior written agreement from all other Parties.

Article 3: Nature of collaboration

- 1. This agreement is entered into among Universities of the "EU Ph.D. Consortium on Metamaterials", listed as Parties.
- 2. The Universities of the Consortium will each appoint one faculty member as Delegate to administer the "EU Ph.D. Programme on Metamaterials". The assembly of Delegates will form the Committee of the EU Ph.D. Consortium on Metamaterials, with a Convenor elected from amongst the Delegates for a period of 3 years.

Article 4: Duration of the Project

- 1. The duration of the project is hereby defined as starting on June 1, 2005 and ending on June 1, 2008.
- 2. A person or entity becomes a Party to this Memorandum upon signature of this Memorandum by a duly authorized representative.
- 3. This Memorandum shall continue in full force and effect

a) until the fulfillment of the Memorandum and complete discharge of all obligations for the carrying out of the *Project* undertaken by the *Parties* under the Consortium Agreement or under this Memorandum, whichever is the later, or

b) until terminated earlier in accordance with Articles 38 or 39 of the Consortium Agreement.

Article 5: Force Majeure

- 1. The Parties agree that the definition for Force Majeure and the consequences with respect to the Parties' rights and obligations in case of Force Majeure under the Consortuim Agreement.
- 2. A Party shall promptly notify the Executive Committee in writing of any Force Majeure that may affect the fulfillment of its obligations under the Consortium Agreement or this Memorandum.

SECTION B: MENTION OF EXCELLENCE

Article 6: Programme leading to the EU Mention of Excellence in Metamaterials for Ph.D.

1. Each University shall conduct Ph.D. programmes and award Ph.D. Degrees according to its own rules and specifications. Each Ph.D. student entered in the EU PhD Consortium on Metamaterials shall be initially enrolled in any one University of the Consortium, to be called the 'Home' University. The Home University shall be the Awarding Institution for the Ph.D. of students enrolled in that Home University.

- 2. Ph.D. students enrolled in the Universities of the Consortium may in addition to the standard Ph.D. requirements of their Home University be eligible for the "EU Mention of Excellence in Metamaterials for PhD" provided that they satisfy the requisites listed in Addendum I. These include a period of not less than 3 months in total spent conducting research in Metamaterials in at least one partner University other than the Home University, to be called a 'Hosting' University.
- 3. While present in a Hosting University the Ph.D. student will be supervised by the Delegate to the Committee of the Hosting University, or by another appropriate person in that Institution nominated by the Delegate. In the latter case, the substitute supervisor should be a designated researcher affiliated or recognised by the EU Network of Excellence in Metamaterials.
- 4. For the award of the EU Mention of Excellence in Metamaterials for Ph.D., a certain number of credit units (see Addendum I) must have been gained from the EU PhD School on Metamaterials. The EU Ph.D. School on Metamaterials is a school on Metamaterials organized by the Consortium itself at various locations that are decided and planned annually; see Addendum II.

Article 7: Award of the Mention of Excellence

- 1. The Mention of Excellence in Metamaterials is awarded by the Committee of the EU Ph.D. Consortium on Metamaterials.
- 2. The application for the Mention of Excellence in Metamaterials must be sent by the applicant to the Convenor of the Committee of the EU Ph.D. Consortium on Metamaterials one month before the final Ph.D. dissertation is examined. The application must document the attainment of all the requisites in Paragraph 4 above.
- 3. The Committee of the EU Ph.D. Consortium on Metamaterials will evaluate the application and will inform the candidate of the result of the evaluation within one month.
- 4. The award of the Mention of Excellence shall take the form of a certificate from the EU Ph.D. Consortium on Metamaterials stating that the awardee has satisfied all the requirements.

SECTION C: FINANCIAL PROVISIONS

Article 8: Funding and costs

1. The issues concerning funding and costs with respect to students' stay in Hosting Universities will be regulated by an additional agreement. At this stage, these issues will be governed by separate ad hoc agreements between the Hosting University and Home University.

SECTION D: GENERAL CONTRACTUAL PROVISIONS

Article 9: The Agreement

1. Interpretation and implementation of this agreement shall be in accordance with all regulations of the Universities of the Consortium.

Article 10: Language

1. This *Memorandum* is drawn up in English, which language shall govern all documents, notices and meetings for its performance and application and/or extension or in any other way relative thereto.

Article11: Settlement of Disputes

- 1. The Parties endeavor to settle disputes amicably.
- 2. In the event of any dispute, difference, controversy or claim arising out of or in connection with this Memorandum, the Parties will first attempt to settle such dispute by consultations in at least two minuted meetings on the subject. The last meeting shall be attended by the Consortium Committee representatives who shall present the case to the Consortium Committee whose decision is final.
- 3. In the event of any dispute, difference, controversy or claim arising after the Project duration has finished will be settled by meeting of respective Parties' representatives.

Addendum I

Requisites for the EU Mention of Excellence in Metamaterials for PhD

The requirements for the award of the Mention of Excellence in Metamaterials are:

- 1. At least three months spent in another University of the Consortium engaged in research in the topic of Metamaterials.
- 2. At least one journal publication jointly authored with a partner belonging to another University part of the Consortium in the field of Metamaterials.
- 3. At least 5 credit units* earned at the EU PhD Schools on Metamaterials.
- 4. At least 3 conference publications in the field of Metamaterials
- 5. The final thesis must be in the field of Metamaterials.

The Consortium Assembly, with a quorum of ³/₄ of all partner organisations, can amend the aforementioned requirements for the Merit of Excellence in Metamaterials if the amendments are approved by a majority of 75% delegates.

* Credit units for taught courses are based on the ECTS Credit scheme.

Addendum II

Structure of the "EU PhD School on Metamaterials

- 1. The EU PhD School on Metamaterials is organized and coordinated by the EU PHD Consortium on Metamaterials.
- 2. The School will present annually courses of taught material whose total value of ECTS Credits is based on their duration.
